COMES NOW, the Plaintiff and in support of its cause of action states to the Court as follows:

COUNT I

1. Sysco Foods Corporation is authorized to bring this action.
2. Defendant Prometheus Inc dba The Bohemian does business at 1029 3rd St SE, Cedar Rapids, IA 52401. Defendant Michael Richards resides at 1106 8th St SE, Cedar Rapids, IA 52401.
3. Defendants purchased from the Plaintiff goods, wares, services, and merchandise pursuant to a written credit application and personal guaranty. A copy of the application with personal guaranty is attached hereto as Exhibit A. A copy of the account summary and invoices are attached hereto as Exhibit B.
4. The prices stated in the attached invoices are those agreed upon or are the actual reasonable prices and values thereof.
5. All of said items and services were received by Defendants.
6. All just payments and credits have been applied to said account.
7. The credit terms provide that the Defendants agreed to pay interest at the rate 18%
8. This action is founded upon the open account obtained pursuant to written terms, and as shown therein there is now owing and unpaid the sum of \$16,011.94 exclusive of interest and costs.

WHEREFORE, Plaintiff prays for a judgment as set forth below.

COUNT II

9. Plaintiff restates Paragraphs 1 through 3 as though fully set forth herein.
10. Plaintiff's goods, wares, services, and merchandise were sold, delivered and

accepted by and beneficial to the Defendants.

11. The actual, reasonable value of the goods, wares, merchandise and services provided by the Plaintiff to the Defendants is not less than \$16,011.94.

WHEREFORE, Plaintiff prays for judgment as set forth below.

COUNT III

12. Plaintiff restates Paragraphs 1 through 3 as though fully set forth herein.

13. Plaintiff thereupon submitted to the Defendants statements of result showing a balance in Plaintiff's favor totaling \$16,011.94 which Defendants accepted and in which Defendants acquiesced.

14. Defendants impliedly agreed to pay said sum by retaining said statements without objection and thus assured said sum would be paid.

WHEREFORE, Plaintiff requests the court enter judgment against the Defendant for \$16,011.94, plus pre-petition interest in the amount of \$2,984.81 and post-petition interest at the contracted rate of 18%, plus a reasonable attorney fee, court costs and such other relief as is just and proper.
