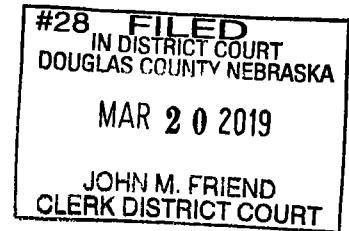



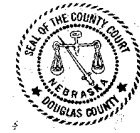

**Facts:** On 14Mar19 at approximately 0730hrs, members of the DEA Group 51A Commercial Interdiction Unit (CIU) were conducting surveillance at a commercial package delivery service located in Omaha, Douglas County, Nebraska. During that time CIU located at package addressed to KEYS, Scyrus at 1110 Marcy Plaza, Omaha, Douglas County, Nebraska. Investigators noted several indicators of possible criminal activity with the package and the package was submitted to a free air sniff by a certified narcotics detection K-9.

The narcotics detection K-9 indicated that there was an odor of narcotics coming from the package and a court authorized search warrant was obtained for the package. The package was opened pursuant to the search warrant and Investigators located 3 saran wrapped bundles of a white powder substance that field tested positive for Cocaine. The bundles weighed 1104g, 1129g, and 1129g for a total of 3362g in packaging. No NE tax stamp was found on the packaging. Investigators located a male named KEYS, Scyrus with the date of birth of 7/7/88 at the address on the label. KEYS had prior weapons and drug arrests.

On 14Mar18 at approximately 1515hrs, CIU attempted a controlled delivery of 1129g of cocaine to 1110 Marcy Plz. An undercover Investigator acting as a package delivery driver knocked on the door of the residence and KEYS (identified by his NE DMV photo) answered the door. The Investigator asked KEYS if he was Scyrus

KEYS and KEYS answered that he was. The Investigator handed the package to KEYS and KEYS took the package into the residence, activating an Anticipatory Search warrant for 1110 Marcy Plz.

Entry was made into the residence and it was secured along with KEYS. A search of KEY'S residence located a loaded Glock handgun on a bookshelf in the living room area in the residence. KEYS refused to make any statement and asked to speak with an attorney.

Dep J Bargstadt S-370, assisted with the operation and is aware of the factual basis pertaining to the arrest of KEYS on 14Mar19.

KEYS was transported to Douglas County Corrections and booked on the listed charges.

Released in the custody of Pre-Trial release, who has agreed to supervise him/her with the understanding that the defendant must follow the supervisor's rules. Release after execution of an appearance bond in the sum of \$750,000.00 and the deposit with the Clerk in cash or other qualified security in the amount of not less than \$25.00 or 10% of the bond.
