The original Declaration, as amended by the First Amendment, Second Amendment, Cancellation of the Second Amendment, Third Amendment, Fourth Amendment and Fifth Amendment is herein referred to as the "Declaration".

Recitals of Fact

- A. Declarant is the declarant under the Declaration as of April 2, 2011.
- B. Declarant now wishes to cancel and terminate the Fourth Amendment.

Cancellation

NOW, THEREFORE, Declarant hereby cancels and annuls the Fourth Amendment and declares the same to be null, void and of no effect, as if the same had never been executed or recorded. The Declaration shall remain in full force and effect as it existed prior to the execution and recordation of the Fourth Amendment, except those amendments made to the Declaration pursuant to the Fifth Amendment shall remain in full force and effect.
