AFFIDAVIT

Corrections to the Plat of Bondfield Heights Addition, an Addition to the City of Omaha, Douglas County, Nebraska, a sub-division of part of the Northwest 1/4 of the Southeast 1/4 of Section 31 Township 15 North, Range 13 East of the 6th PM.

I, the undersigned Registered Land Surveyor, do hereby submit this Revised Plat of Bondfield Heights Addition in order to correct the legal description as shown in the Surveyors Certificate and to correct the side distances shown on Lots 1, 2, 3, 4, 5, and 6 Block 1, all as shown and recorded in Book 1190 Page 119 of the records of the Register of Deeds in the Douglas County Court House, Omaha, Nebraska. The corrections as shown hereon do not alter, change or affect any easements for electric and telephone poles and lines or the street dedication as platted.

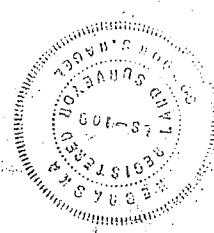
The corrected legal description is as follows:

Commencing at the Northeast corner of the Northwest 1/4 of the Southeast 1/4 of Section 31 Township 15 North Range 13 East of the 6th PM, Douglas County, Nebraska; Thence South along the East line of the Northwest 1/4 of the Southeast 1/4 of said Section 31, a distance of 461.2 Feet; Thence Westerly on a line bearing South 89°46'40" West a distance of 546.45 Feet to the point of beginning; said point being on the South Right of Way line of "A" Street; Thence continuing Westerly on the said line bearing South 89°46'40" West and on the said South Right of Way line of "A" Street a distance of 503.45 Feet; Thence Southerly on a line bearing South 0°33'20" East a distance of 400 Feet; Thence Easterly on a line bearing North 89°47'40" East a distance of 501.45 Feet; Thence Northerly on a line bearing North 0°16'50" West a distance of 400 Feet to the point of beginning.

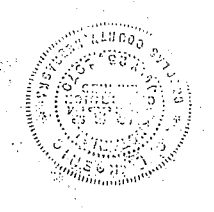

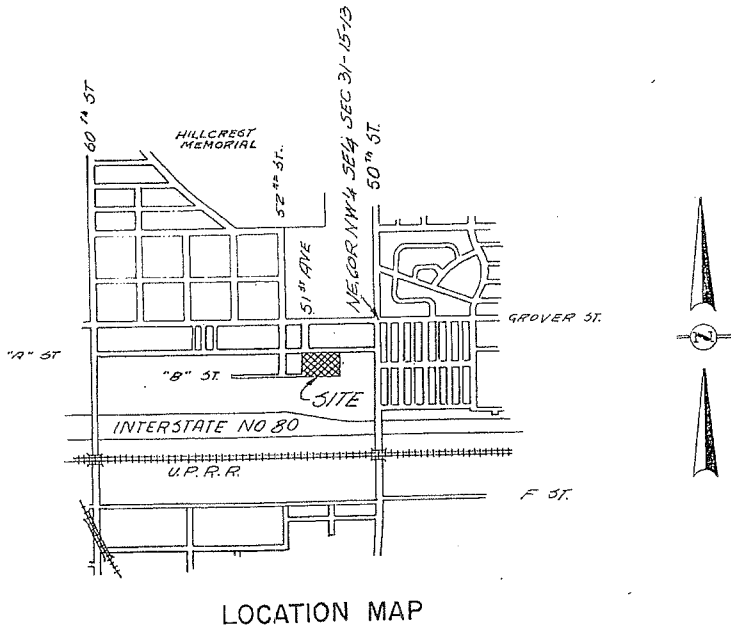
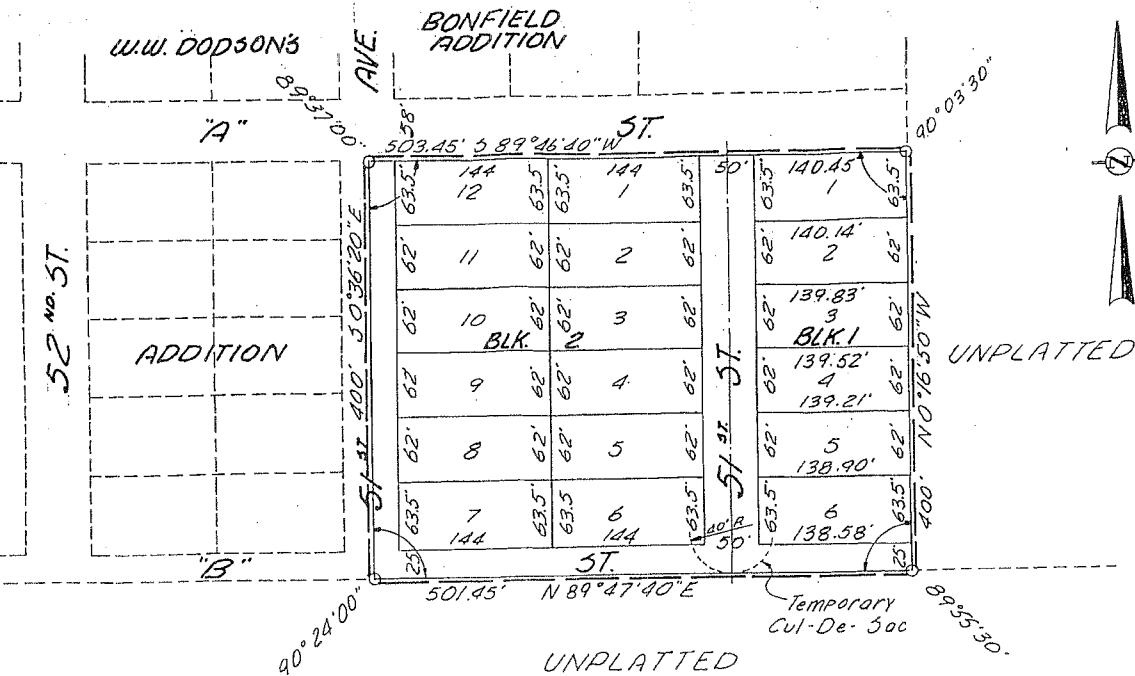
