The undersigned, Sylvia Ball, being first duly sworn states that she is the Clerk of Sanitary and Improvement District No. 32 of Sarpy County, Nebraska and makes the following statement regarding same:

1. The name of the District is: Sanitary and Improvement District No. 32 of Sarpy County, Nebraska.
2. The outer boundaries of the District are: See Exhibit "A" attached hereto.
3. The purposes for which the District was formed are as follows: To acquire, install, repair, maintain, renew and/or replace sanitary and storm sewer system, a water system, a civil defence warning system, a system of sidewalks, public roads, streets, and highways, public waterways, docks or wharfs, and related appurtenances, to contract for water for fire protection and for resale to residents of the District, and to contract for gas and for electricity, street lighting for the public streets and highways within said District, to construct and to contract for the construction of dikes and levees for flood protection for the District, and to acquire, improve and operate public parks, playgrounds and recreational facilities. The District, in lieu of establishing its own water system, may contract with any utilities district, municipality or corporation for the installation of a water system and to provide water service for fire protection and for the use of the residents of the District.
4. The District has the power to levy an unlimited property tax to pay its debt and its expenses of operation and maintenance.
5. The District is required by statute to levy special assessments on property in the District to the full extent of special benefits arising by reason of improvements installed by the District.
6. In all years when a budget is required by law, the District's annual budget is filed with the County Clerk, which budget shows anticipated revenue and expenses, mill levy, and indebtedness of the District.
7. The actual current mill levy of the District may be obtained from the County Clerk.

8. A copy of the District's annual financial audit is on file with the Clerk of the District and the State Auditor of Public Accounts.
