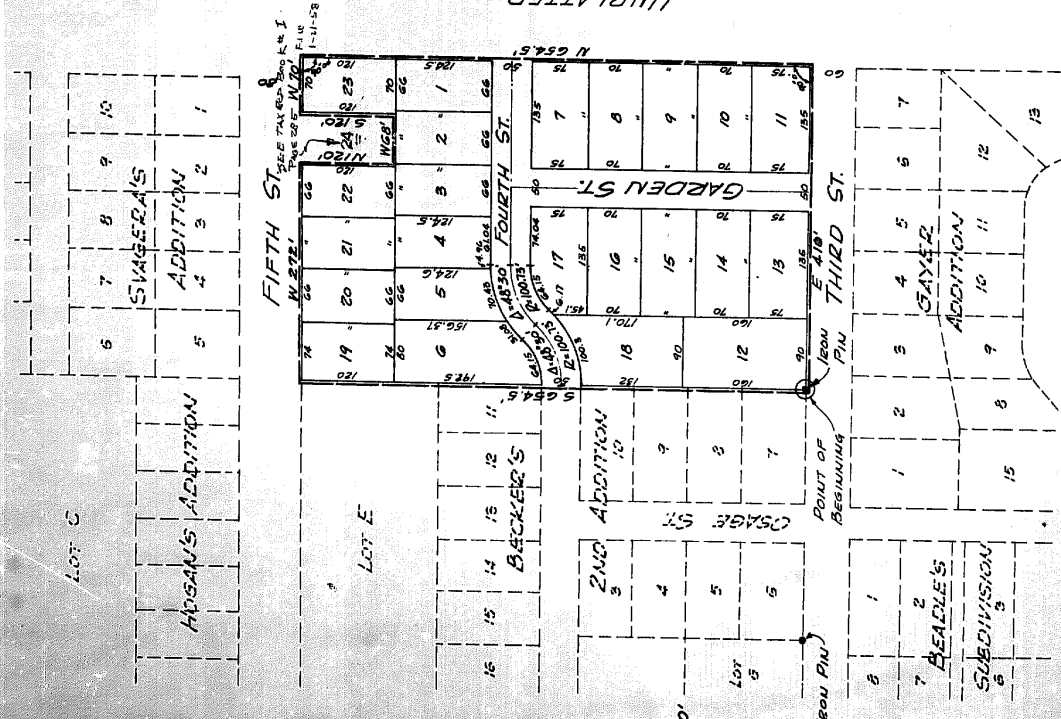


# BECKER'S 3RD ADDITION

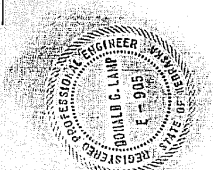
## SURVEYOR'S CERTIFICATE

I hereby certify that I have accurately surveyed and staked with iron pipe all corners of all lots, streets, angle points and ends of all curves in Becker's 3rd Addition, a deposit of Lot "4" Beader's Subdivision together with vacated North 10.0 feet of Third street adjoining on the South and a deposit of Lots 1 to 8 inclusive, Block 3, Beader's Subdivision on Addition to the City of Papillon, except the West 30 feet of Lot 2 and the East 38 feet of Lot 3 and except the North 20 feet thereof deeded to the City of Papillon.
