## SURVEYOR'S CERTIFICATE

I certify that I have accurately surveyed with iron pipe all corners of streets, angle points and ends of lots in Becker's 3rd Addition, a Replat of Beadle's Subdivision together with the North 10.0 feet of Third street adjacent to the South and a Replat of Lots 1 and 2, Block 3, Beadle's Subdivision, together with the North 10.0 feet of Lot 2 and the East 38 feet of Lot 3 and except the North 20 feet of Lot 4 added to the City of Papillion. 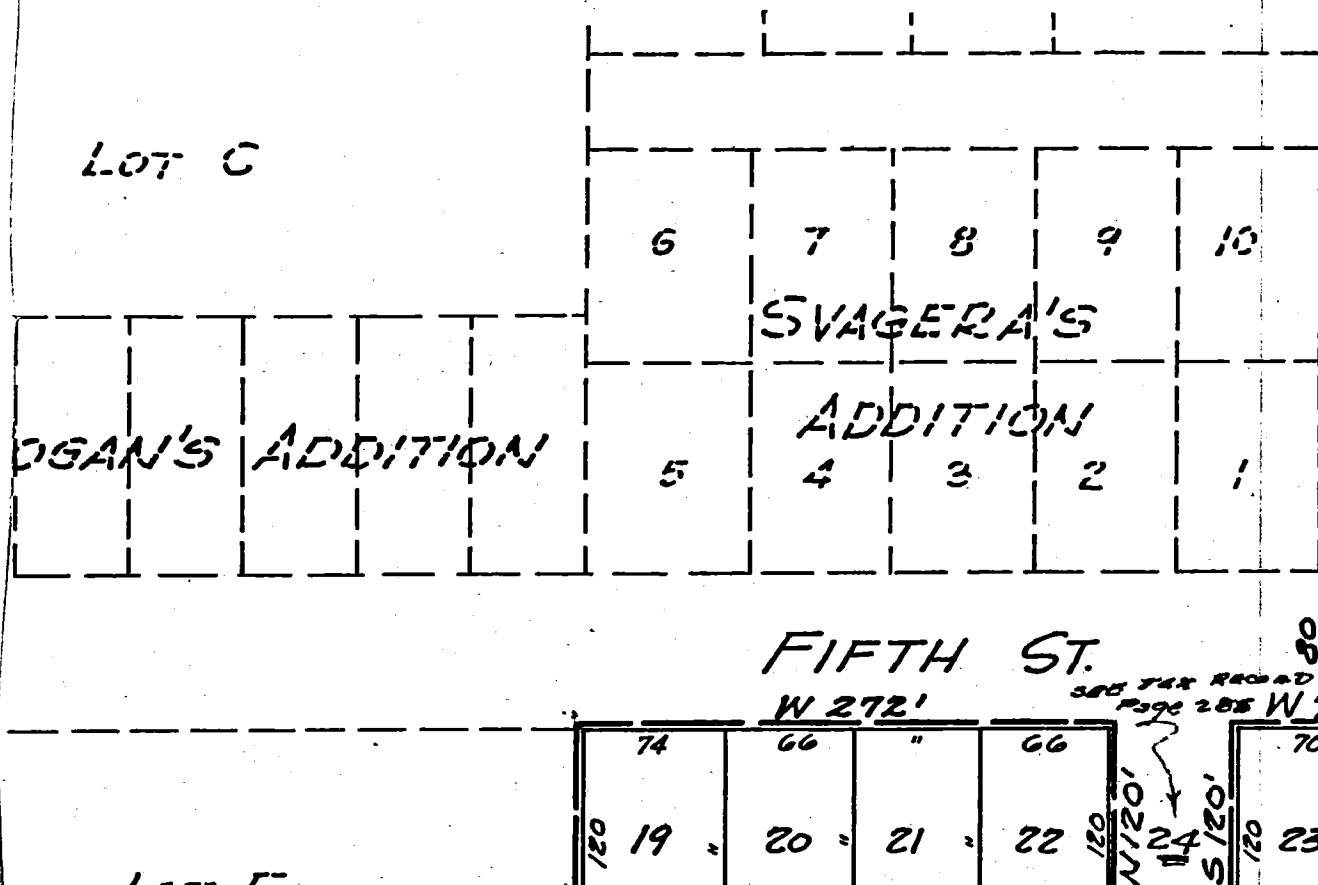
## DEDICATION

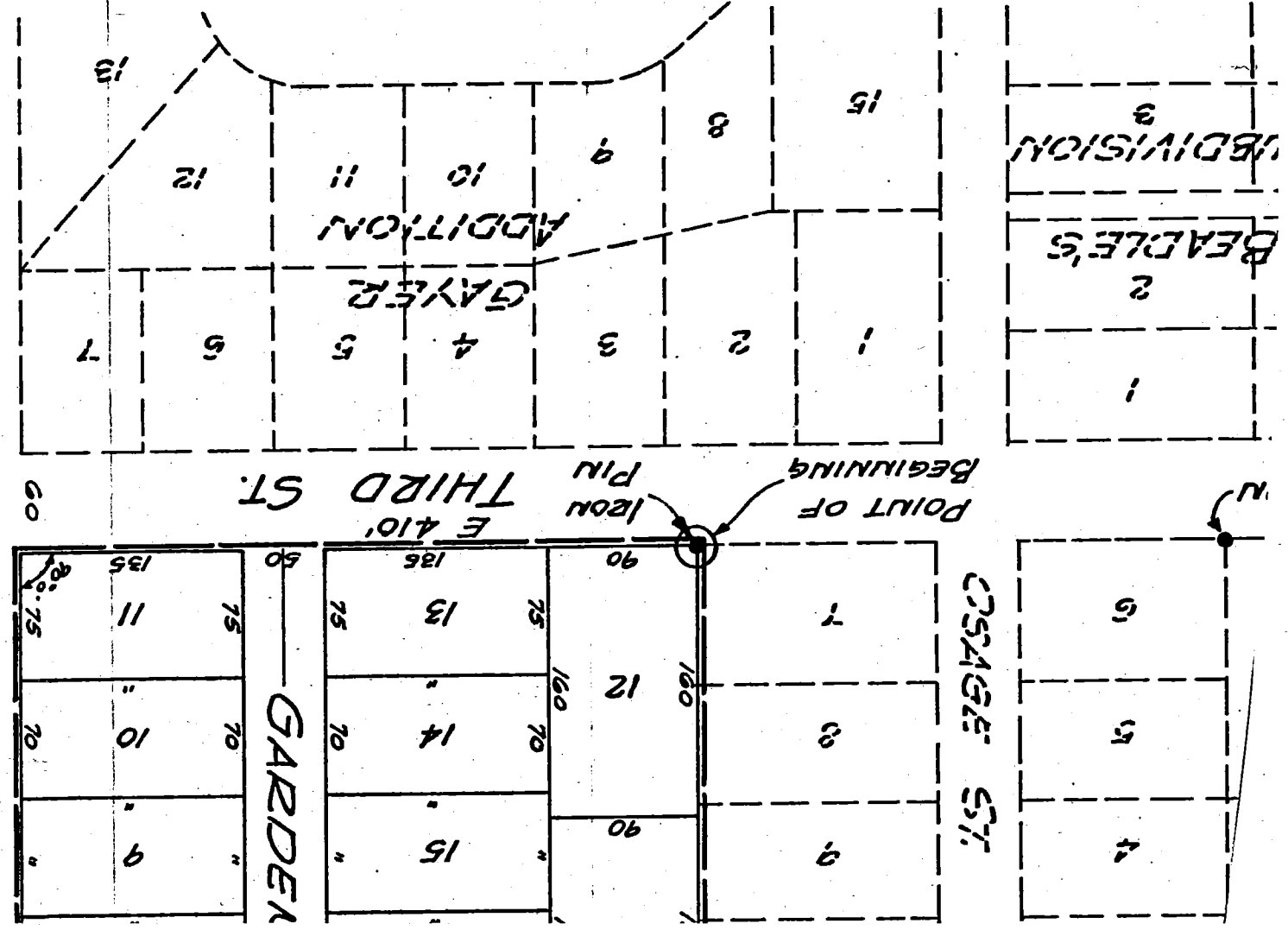
