


Last Will and Testament

Norma D. Veskerna




SECOND: I hereby authorize and direct my said personal representative to pay the expenses of my burial, purchase a suitable headstone for my grave, and pay, from the residue of my estate, all state inheritance taxes and federal estate taxes that may be due by reason of my death. I further empower my personal representative to convert any or all of my real and personal property into cash under such terms and conditions as he deems proper without first obtaining the order or approval of any court, and to distribute my estate in cash or in kind.

FOURTH: I devise, give and bequeath all of my estate, whether real or personal, as follows:

- b) All the rest, residue and remainder of my estate I devise to my brother, Earl H. Veskerna. If she predeceases me or disclaims any property or assets devised to her, I devise any such assets, including the family farm, to St. Paul's Lutheran Church, Omaha, Nebraska.
