AMENDMENT TO MASTER DEED AND DECLARATION CREATING BOARDWALK CONDOMINIUM PROPERTY REGIME

THIS AMENDMENT to the Master Deed and Declaration dated October 29, 1979, and recorded in the Office of the Register of Deeds of Douglas County, Nebraska at Miscellaneous General Book 684, Page 626, is made this 23 to day of 1985, by the Boardwalk Association, Inc., a Nebraska nonprofit corporation, successor to Boardwalk, Ltd., a Nebraska limited partnership.

This Amendment is made following the affirmative vote of three fourths (3/4) of the total basic value of the Condominium Regime, cast in person or by proxy at a meeting duly held in accordance with the provisions of the By-Laws held on January 15, 1985.

In accordance with such vote, Article IX, Section d, the fourth paragraph is deleted, and replaced by the following:

damage is caused to common the elements or an apartment or apartments owned by others as a result of any condition in an apartment of a co-owner, whether or not such condition is the result of any natural condition, intentional or negligent act of a co-owner, or his agent, servant, tenant, family member, invitee, licensee, household pet, or if such act otherwise requires maintenance, repair or replacement which would otherwise be a common expense, then such co-owner shall pay for such damage or such maintenance, repair, and replacement, in the amount as may be determined by the Association; provided, however, that the provisions of this paragraph are subject to the provisions of paragraph 5 hereof providing for waiver of subrogation rights with respect to casualty damage insured against under the policies of insurance maintained by the Association.
