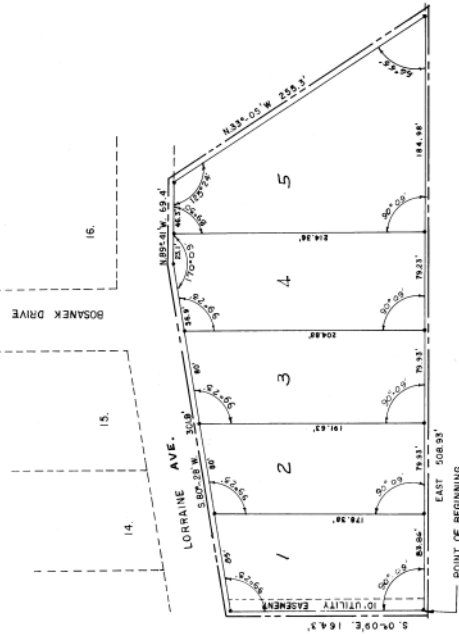


2nd. ADDITION TO BOSANEKS ORCHARD HEIGHTS
