## AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR BRENTWOOD PARK ADDITION

The Declaration of Covenants, Conditions, Restrictions and Easements for Brentwood Park Addition in the City of Fremont, Dodge County, Nebraska was recorded with the Register of Deeds of Dodge County, Nebraska, on April 30, 1992, and filed at Book 219, Page 439; and said Declaration is hereby amended by amending ARTICLE 1,4., which shall provide as follows:

4. The exposed front foundation wall as well as any foundations wall facing a street of all main residential structures must be construed of or faced with brick or simulated brick or stone or stucco or other approved material. All exposed side and rear concrete or concrete block foundations walls not facing a street must be painted. All driveways must be constructed of concrete, concrete blocks, brick or stone. Fireplace chimneys shall be covered with brick, stone or siding. Unless other comparable materials are specifically approved by Don Peterson & Associates Real Estate Company. The roof of all improvements shall be covered with wood shingles or with minimum 40 year architectural laminated shingles or approved alternative by Don Peterson & Associates Real Estate Company.
