AMENDMENT TO DECLARATION OF COVENANCE 10 PM 12: 25 RESTRICTIONS AND EASEMENTS FOR BRENTWOOD PARK 2ND ADDITION

5. The exposed front foundation wall as well as any foundations wall facing a street of all main residential structures must be construed of or faced with brick or simulated brick or stone or stucco or other approved material. All exposed side and rear concrete or concrete block foundations walls not facing a street must be painted. All driveways must be constructed of concrete, concrete blocks, brick or stone. Fireplace chimneys shall be covered with brick, stone or siding. Unless other comparable materials are specifically approved by Don Peterson & Associates Real Estate Company. The roof of all improvements shall be covered with wood shingles or with minimum 40 year architectural laminated shingles or approved alternative by Don Peterson & Associates Real Estate Company.
