

## ASSOCIATION AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR CAMBRIDGE ESTATES, A SUBDIVISION IN DOUGLAS COUNTY, NEBRASKA

This Amendment to Declaration of Covenants, Conditions, Restrictions and Easements of Cambridge Estate (this "Amendment") is made and entered into effective the 17<sup>th</sup> day of August, 2013, by the undersigned.

## PRELIMINARY STATEMENT

WHEREAS, the Declaration of Covenants, Conditions, Restrictions and Easements for Cambridge Estates dated April 1, 1993, and filed with the Douglas County Register of Deeds on April 7, 1993, in Miscellaneous Book No. 1065, Page 577 and any amendments thereto (the "Declaration") governs the ownership and use of real estate legally described on Exhibit "A" and incorporated herein by reference (the "Lots");

WHEREAS, the provisions of the Declaration provide that the Declaration may be amended by writing and signed by not less than ninety percent (90%) of the owners of the Lots;

WHEREAS, the undersigned desire to amend the Declaration as set forth herein.

NOW, THEREFORE, the undersigned amend the Declaration as set forth below:

- 1. <u>Definitions.</u> Except as context clearly requires otherwise or as defined herein, capitalized terms shall have the same meaning as set forth in the Declaration.
  - 2. <u>Amendment.</u> The Declaration is hereby amended as follows:

A new Article VI shall be added to the Declaration as follows:

Article VI.
Homeowners Association.

A. The Owner of each Lot subject to the Declaration shall be a member of the Cambridge Estates Homeowners Association, a Nebraska non-profit corporation to be formed by the members thereof (the "Association").

B. The Association shall, as its primary function, collect and spend dues for the benefit of the members to maintain the appearance of properties in and around the neighborhood, whether owned by the Association or maintained under easements or other agreements.

- C. Each member shall be required to pay dues to the Association. Dues for the first year of assessment shall not exceed One Hundred and 00/100 Dollars (\$100.00) per year. Thereafter, the maximum general assessment shall increase ten percent (10%) per annum. The amount of dues shall be established by the Board of Directors of the Association, except that any dues in excess of the maximum established by this section must be approved by a two-thirds majority of the members in attendance at a meeting of the Association.
- D. The Association shall have the authority to file liens against any Lot owned by a member of the Association as delinquent in paying dues to the Association. The Association may take legal action to enforce or foreclose its liens, together with interest, attorney fees and costs associated therewith.
- E. The Association shall have the authority to enforce the requirements of the Declaration and any Owner.
- 3. <u>Miscellaneous</u>. Except as expressly amended herein and as set forth in any other duly recorded amendment to the Declaration, the Declaration shall continue in full force and effect according to its terms.




