CERTIFICATE

Pursuant to Section 31-727.01 of the Revised Statutes of Nebraska, 1943, as amended, I, the undersigned Clerk of Sanitary and Improvement District No. 351, of Douglas County, Nebraska ("SID No. 351), hereby certify to the following:

- 1. The number of this Sanitary and Improvement District is No. 351.
- 2. A copy of the outer boundaries of SID No. 351 is attached hereto as Exhibit "A", and incorporated herein by reference.
- 3. The purposes of SID No. 351 shall be to acquire, install, repair, maintain, renew and replace a sanitary and storm sewer system, a water system, a civil defense warning system, a system of sidewalks, public roads, streets, and highways, public waterways, docks or wharfs, and all appurtenances related to the foregoing; to contract for water for fire protection and for resale to residents of SID No. 351, to contract for police protection and security services, and to contract for gas and for electricity for street lighting for the public streets and highways within SID No. 351, to construct electric service lines and conduits, and gas mains, or to contract for the construction of dikes and levees for flood protection for SID No. 351; where permitted by law, to contract with other sanitary and improvement districts to acquire, build and improve and operate public parks, playgrounds, and recreational facilities for the joint use of the residents of the contracting districts; where permitted by law to enter into Interlocal Cooperation Agreements with other governmental authorities and subdivisions and to acquire, improve and operate public parks, playgrounds and recreational facilities. In lieu of establishing its own water system, SID No. 351 may contract with any utilities district, municipality or corporation for the installation of a water system and to provide water service for fire protection and for the use of residents of SID No.
- 4. SID No. 351 has the power to levy an unlimited property tax to pay the debt and its expenses of operation and maintenance.
- 5. SID No. 351 is required to levy special assessments on the property in SID No. 351 to the full extent of special benefits arising by reason of improvements installed by SID No. 351.
- 6. Since SID No. 351 is newly organized, it has not yet filed its annual budget with the Douglas County Clerk. At a later date it will file a budget with the Douglas County Clerk
