Andresen, et ux. on the 12th day of January, 1962, recorded on the 21st day of March, 1962, in Book 378 of Misc., at Page 49, in and for Douglas County, Nebraska (hereinafter referred to as "Easement"); and

WHEREAS, Northern executed a Release of Easement the 4th day of August, 2006, which was recorded the 7th day of August, 2006, as Document No. 2006088945 in and for Douglas County, Nebraska (hereinafter referred to as "Release"), and the premises named therein were incorrectly described; and

WHEREAS, Northern, by this document, intends to correct said legal description and to release and discharge only the lands described below from the operation and effect of said Easement without prejudice to its rights in and to any other lands therein described.

NOW, THEREFORE, NORTHERN does hereby correct the legal description recited in the Release to read as follows and does hereby quitclaim and release unto the current owners of record any and all rights or interest it may have pursuant to the above said Easement in and to the following described lands only:

Lots 3 and 1 in the Northwest Quarter (NW¼) (79.12 acres) of Section 16, Township 15 North, Range 11 East, EXCEPT a 90 foot wide strip centered on Northern's existing 16-inch pipeline, in Douglas County, Nebraska.

All other rights under said Easement are retained by Northern.
