

ORDINANCE NO. _____

AN ORDINANCE TO ANNEX CERTAIN REAL
ESTATE TO THE CITY OF PAPILLION,
NEBRASKA

BE IT ORDAINED by the Mayor and City Council of the City of Papillion, Nebraska:

Section 1. That the following described real estate, to-wit:

A part of Tax Lot 7 (said Tax Lot 7 being the east fifty acres of the North half of the Northwest Quarter) of Section 35, Township 14 North, Range 12, East of the 6th M., Sarpy County, Nebraska, described as follows:

Beginning at the Southwest corner of said Tax Lot 7 and a point 990.00 feet east of the Southwest corner of the North one-half of the Northwest Quarter of said Section 35, said point being on the South line of the North one-half of the Northwest Quarter; thence North $00^{\circ} 00' 12''$ West (assumed bearing) along the West line of the East 50 acres of the Northwest Quarter of said Section 35 a distance of 1045.69 feet; thence South $89^{\circ} 50' 16''$ East a distance of 153.73 feet; thence North $00^{\circ} 00' 12''$ West a distance of 283.47 feet; thence South $89^{\circ} 47' 12''$ East along the North line of the Northwest Quarter of said Section 35 a distance 385.00 feet; thence South $00^{\circ} 12' 48''$ West a distance of 175.00 feet; thence North $89^{\circ} 47' 12''$ West a distance of 14.04 feet; thence Southerly on a 575.00 foot radius curve to the right a distance of 81.50 feet; thence North $89^{\circ} 47' 12''$ West a distance of 182.39 feet; thence South $07^{\circ} 18' 14''$ West a distance of 80.62 feet; thence South $08^{\circ} 22' 54''$ West a distance of 80.81 feet; thence South $04^{\circ} 22' 33''$ West a distance of 80.21 feet; thence South $00^{\circ} 24' 30''$ West a distance of 80.01 feet; thence South $03^{\circ} 36' 42''$ East a distance of 80.17 feet; thence South $07^{\circ} 35' 36''$ East a distance of 80.75 feet; thence South $11^{\circ} 29' 57''$ East a distance of 76.60 feet; thence South $14^{\circ} 37' 32''$ East a distance of 77.58 feet; thence South $06^{\circ} 45' 53''$ East a distance of 75.56 feet; thence South $05^{\circ} 09' 06''$ West a distance of 75.28 feet; thence South $18^{\circ} 10' 02''$ West a distance of 69.35 feet; thence South $20^{\circ} 36' 55''$ West a distance of 90.69 feet; thence South $06^{\circ} 56' 15''$ West a distance of 90.57 feet; thence South $00^{\circ} 12' 10''$ West a distance of 33.00 feet; thence North $89^{\circ} 47' 50''$ West along the South line of the North one-half of the Northwest Quarter of said Section 35 a distance of 288.65 feet to the point of beginning
