

ORDINANCE NO. 501

AN ORDINANCE TO ANNEX CERTAIN REAL ESTATE TO THE CITY OF
PAPILLION, NEBRASKA.

BE IT ENDAKED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF
PAPILLION, NEBRASKA,

SECTION 1. That the following described real estate, to-wit:

acres of the North one-half of the Northwest Quarter of
