ORDINANCE NO. 482

AN ORDINANCE TO-ANNEX CERTAIN REAL ESTATE TO THE CITY OF PAPILLION, NEBRASKA

BE IT ORDAINED by the Mayor and City Council of the City of Papillion, Nebraska:

Section 1. That the following described real estate, to-wit:

A part of Tax Lot 7 (said Tax Lot 7 being the east fifty acres of the North half of the Northwest Quarter) of Section 35, Township 14 North, Range 12, East of the 6th P.M., Sarpy County, Nebraska, described as follows:

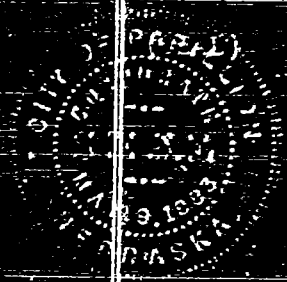
