



SURVEYOR'S CERTIFICATE

This is to certify that I have accurately surveyed and set iron pipe on all lot corners in Cascio Addition #1, as laid out by me on a tract of land in Lot 1, Gregg's Choice Acres, which lies wholly within the North 1/2 of Section 26, T14N, R13E, of the 6th P.M., Sarpy County, Neb., more particularly described as follows: The point of beginning being 1926.64 feet northerly of the center of Section 26, T14N, R13E along the quarter section line, thence to the right 90°48' and bearing east a distance of 752.01 ft, thence to the left 90°00' and bearing south a distance of 89°02' and bearing east a distance of 368.69 ft, thence to the right 89°02' and bearing south a distance of 820.0 ft, thence to the right 90°58' and bearing west a distance of 198.69 ft, thence to the right 89°02' and bearing north 00°58' W a distance of 51.85 feet, thence to the left 89°02' and bearing west a distance of 746.5 ft, thence to the right 100°20' and bearing north 20' E a distance of 344.63 ft, thence to the left 108°15' and bearing west a distance of 328.65 ft, thence to the left 6°45' and bearing south 89°15' W a distance of 79.13 ft, thence to the left 96°44' and bearing south 13°29' E a distance of 35 feet, thence to the right 96°59' and bearing south 83°30' W a distance of 187.29 ft, thence to the right 83°45' and bearing north 12°45' W a distance of 174.5 ft, thence to the right 02°18' and bearing north 15°53' W a distance of 50.16 ft, thence to the right 01°34' and bearing north 15°27' W a distance of 341.3 ft, thence to the right 105°27' and bearing east a distance of 446.33 ft to the point of beginning, containing 21.7 acres more or less all in Sarpy County, Neb.
