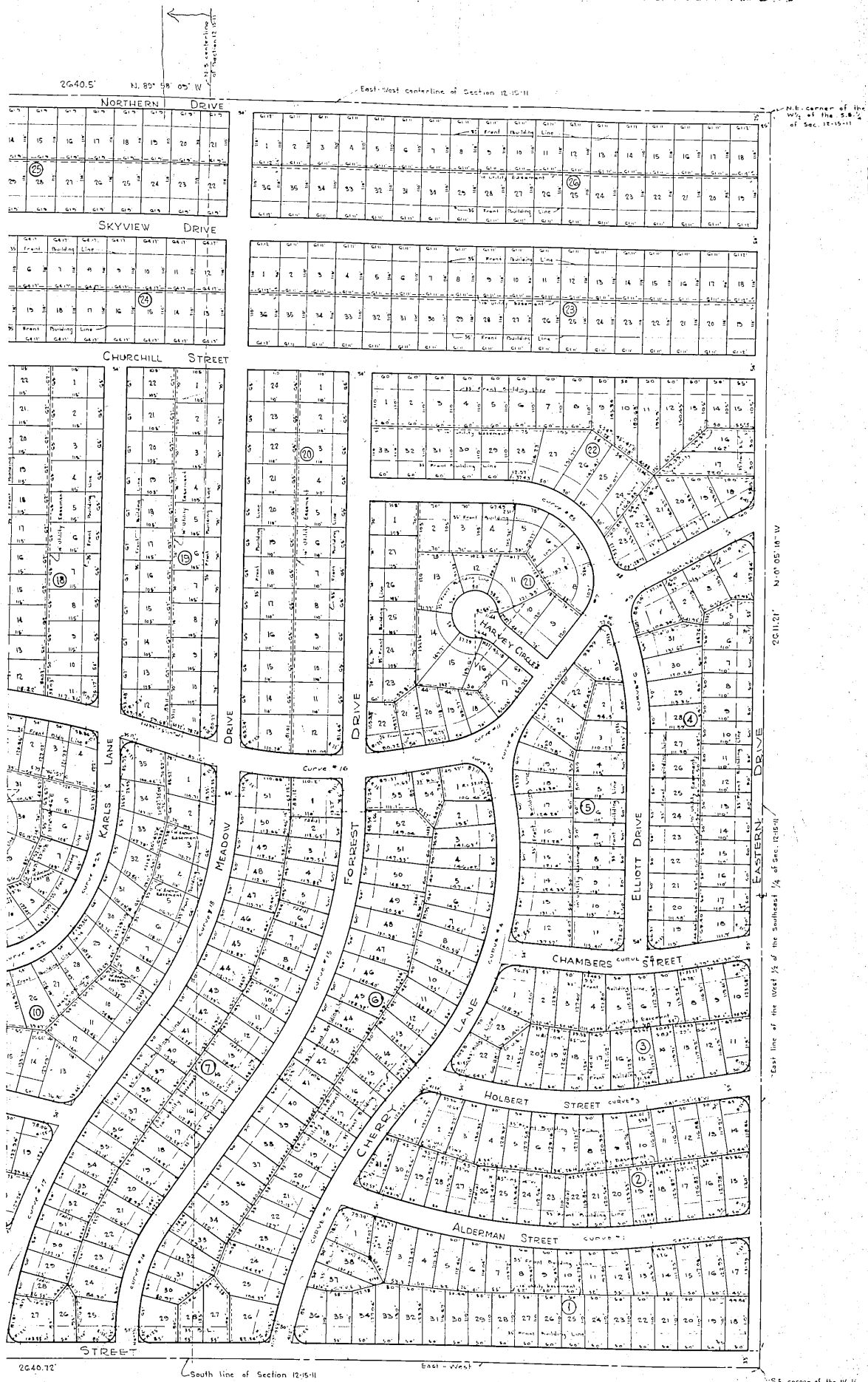

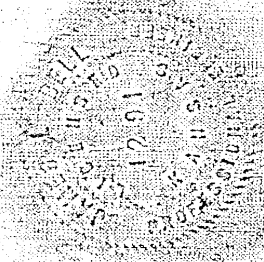
SURVEYORS CERTIFICATE

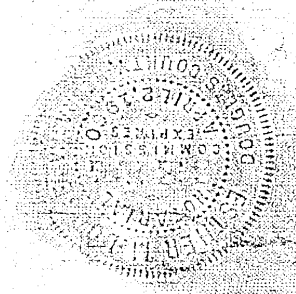
