ANCHOR AND DOWN GUY EASEMENT

<u>METROPOLITAN UTILITIES DISTRICT</u>, owner of the real estate described as follows, and hereafter referred to as "Grantor".

That part of the Northwest Quarter (NW¼) of Section Thirty-two (32), Township Sixteen (16) North, Range Twelve (12) East of the 6th P.M., Douglas County, Nebraska, lying south of Military Road.

NE NW SE SW

In consideration of the sum of (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, do hereby grant to the OMAHA PUBLIC POWER DISTRICT, its successors and assigns, hereafter referred to as "District", a permanent easement, with rights of ingress and egress thereto, to install and maintain anchors and down guy wires upon, over and under that portion of the above described real estate as follows:

See the Exhibit "A" on the reverse side of this document for a sketch of the easement area.

CONDITIONS:

The District shall install and maintain on said down guy wire(s) suitable and durable protective devices or guards.

After anchors and down guys have been installed, no permanent buildings or other structures shall be placed in or encroach the easement and no change in grade elevation or any excavations shall be made therein without prior written approval of the District, but the same may be used for landscaping or other purposes that do not then or later interfere with the granted easement uses.

The foregoing right is granted upon the express condition that the District will assume liability for all damages to the above described property caused by the Districts failure to use due care in its exercise of the granted right.

It is further agreed Grantor has lawful possession of said real estate, good, right and lawful authority to make such conveyance and that his/their heirs, executors, administrators, successors and assigns shall warrant and defend the same and will indemnify and hold harmless the District forever against the claims of all persons whomsoever in any way asserting any right, title or interest prior to or contrary to the conveyance.


