## Exhibit "A"

## DESCRIPTION OF REAL PROPERTY - HOLT COUNTY, NEBRASKA

An irregular tract of land located in the North ½ of Section 21, T28N, R10W of the 6<sup>th</sup> P.M., Holt County, Nebraska, described as follows: Commencing at the southeast corner of the said North ½; thence S 89° 06′ 05″ W (assumed bearing) on the south line of said North ½, a distance of 679.80 feet to the southwest corner of a tract of land as recorded in Deed Book 170, Page 620, also being the True point of beginning; thence N 01° 06′ 24″ W on the west line of said tract of land, a distance of 646.80 feet to the northwest corner of said tract of land; thence S 89° 06′ 05″ W parallel with said south line of the North ½, a distance of 1362.52 feet; thence S 51° 18′ 26″ W, a distance of 105.43 feet to said south line of the North ½; thence N 89° 06′ 05″ E on said south line of the North ½, a distance of 2198.89 feet to the point of beginning, containing 26.441 acres of land, more or less.
