- (2) Grantee shall have the right, from time to time, after completing the installation of an initial pipe line hereunder, to construct and install one or more additional pipe lines hereunder upon payment to Grantor, his heirs or assigns of an additional sum of \$1.00 for each such additional line.
- (3) Said Grantor agrees that the Kansas-Nebraska Natural Gas Company has hereby granted the right to install a tap and meter in the fence line or directly inside thereof for the purpose of servicing the pipe line herein mentioned.
- (4) It is agreed by Grantors that any payment of consideration due under the terms hereof may be made jointly to Grantors and any <u>hmorqadee</u>s of record at the time such payment
