Lloyd C. Smith, being first duly sworn, or upon affirmation, deposes and says that he is a Nebraska Registered Land Surveyor, duly authorized to conduct surveys in the State of Nebraska. Affiant states that he did survey the following described real estate and complete a Plat of Survey on or about the 5th day of November 2003 as shown on the attached Plat of Survey marked Exhibit "A" and incorporated herein by this reference, to-wit:

Township 30 North, Range 20, West of the 6th P.M.
