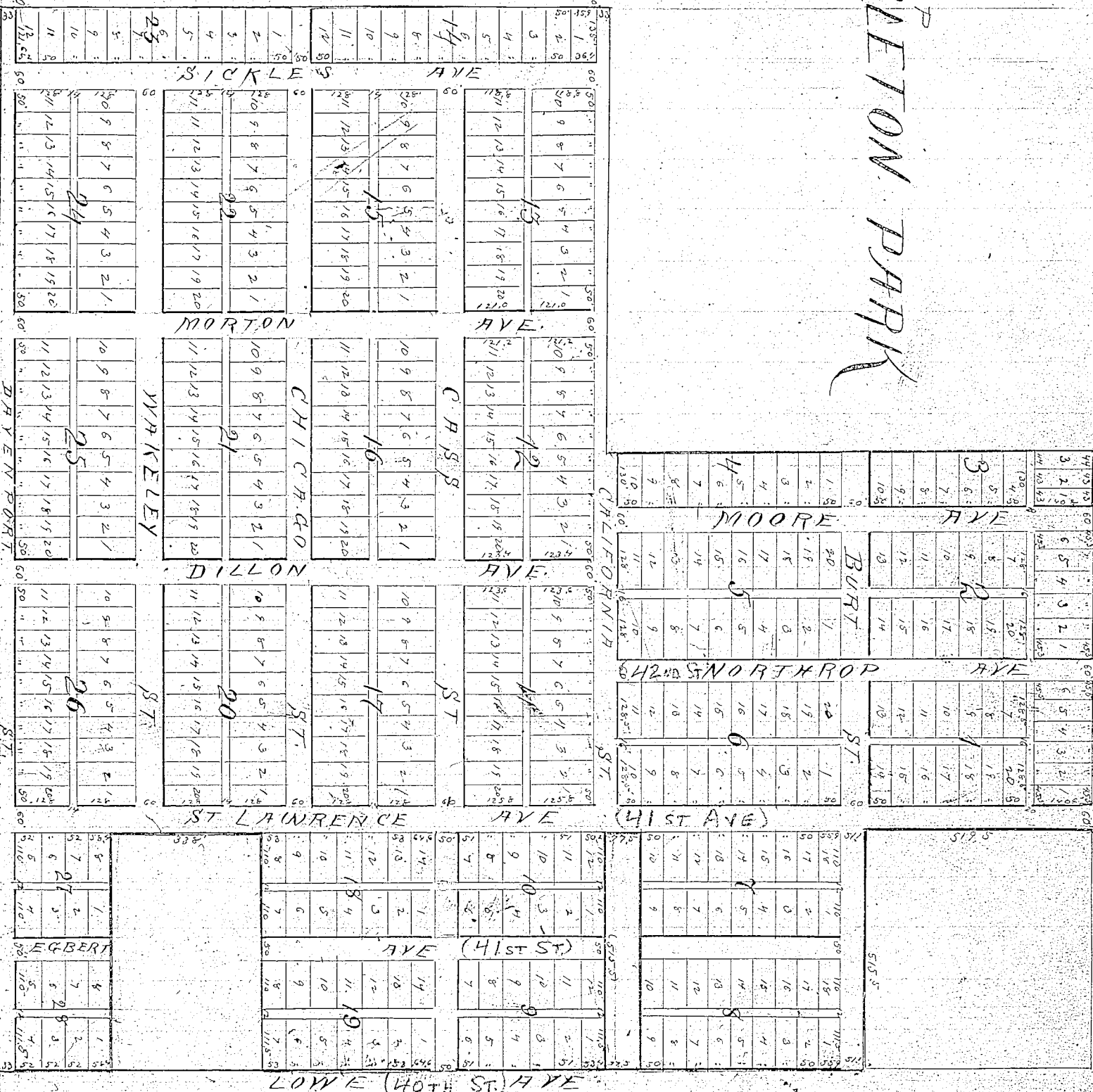

Neb. said point being in the East line of Right of Way of the "Omaha Belt Ry." thence East 2377.5 feet to the West line of "Lowe Ave." thence North along the West line of Lowe Ave. 247.4 feet, thence West 515.5 feet, thence North 338 feet, thence East 515.5 feet to the West line of Lowe Ave. thence North along West line of said Avenue 741 feet, thence West 515.5 feet, thence North 77.5 feet, thence East 515.5 feet to the West line of "Lowe Ave." thence North along West line of said Lowe Ave. 507.4 feet, thence West 515.5 feet, thence North 579.5 feet to the South line of "Cunning St." formerly "Mercer Ave." thence West along the South line of said "Cunning St." 855 feet, thence South 1104 feet, thence West 1020.5 feet to a point in the East line of the Right of Way of the Omaha Belt Ry. thence South along said line 1303.9 feet to point of Beginning.

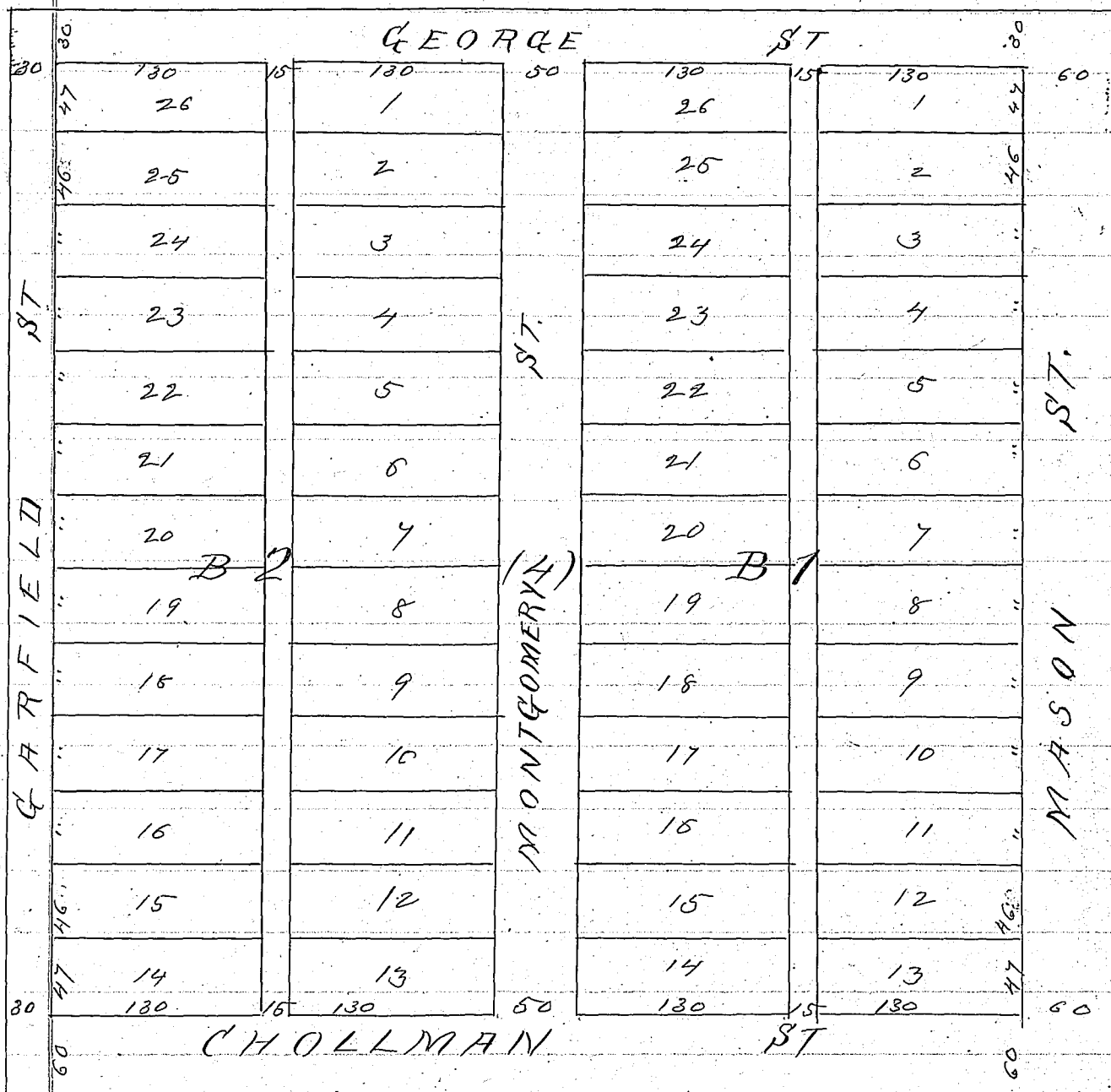
