EXHIBIT "B"

- All fixtures, equipment, goods, machinery, and all other articles of personal property now or (a) hereafter attached to, located upon, used, or adapted for use in the operation of, the real estate described on Exhibit "A" ("Trust Property"), including without limitation, all heating, cooling, air conditioning, ventilating, refrigeration, generating, lighting, plumbing, power, water, lifting, laundry, maintenance, incinerating, cleaning, fire prevention and extinguishing, security and access control, gas, cooling, electric and communication fixtures, equipment and apparatus, all pipes, pumps, tanks, motors, engines, dynamos, conduits, transformers, oil burners, ducts, compressors, water heaters, furnaces and boilers, all ovens, ranges, stoves, refrigerators, disposals, dishwashers, washing and drying machines and other appliances, all escalators and elevators, all cabinets, partitions, built-in mirrors, mantels, panels, shades, windows and sashes, all carpeting, underpadding and draperies, all furnishings of public spaces, halls and lobbies, and all shrubbery and plants; provided, there shall be excluded from the foregoing any fixtures, equipment and tangible personal property which (i) is owned by tenants of the Trust Property, or (ii) owned by any lessors who have leased the same to tenants of the Trust Property; and
- (b) All present and future contracts and policies of insurance which insure the Trust Property, or any such fixtures or personal property, against casualties and other hazards or contingencies, and all monies and proceeds and rights thereto which may be or become payable by virtue of any such insurance contracts or policies; and
- (c) All condemnation awards or proceeds from condemnation or other taking or conveyance in lieu thereof; and
- (d) All the rents, revenues, issues, profits and income of the Trust Property, and all right, title and interest in and to all present and future leases and other agreements for the occupancy or use of all or any part of the Trust Property, and all right, title and interest of Debtor thereunder, including without limitation, all cash or security deposits, advance rentals and deposits or payments of similar nature, together with all guaranties of tenants' or occupants' performances thereunder; and
- (e) All general intangibles relating to the development or use of the Trust Property, including without limitation, all permits, licenses and franchises, all names under or by which the Trust Property may at any time be operated or known, and all rights to carry on business under any such names or any variant thereof, and all trademarks, trade names, logos and goodwill in any way relating to the Trust Property; and
- (f) All shares of stock or other evidence of ownership of any part of the Trust Property that is owned by Debtor in common with others and all documents of membership in any owners' or members' association or similar group having responsibility for managing or operating any part of the Trust Property.
