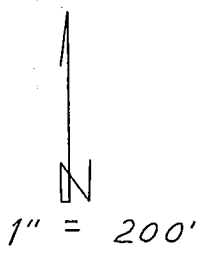
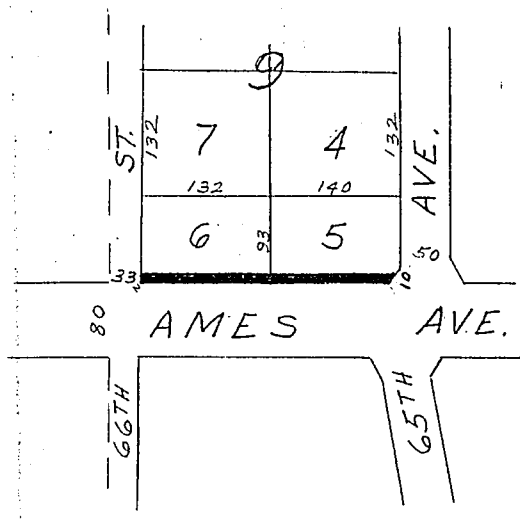


PLAT AND DEDICATION FOR STREET WIDENING
