THIS MATTER came on for hearing on the <u>ro</u> day of February, 2012 on the Plaintiff's Motion for an Order compelling Defendant's cooperation and approval of any and all necessary documentation to facilitate the release of information and the implementation of a Qualified Domestic Relations Order (QDRO) complying with paragraph 8(p) of the Decree of Dissolution as it relates to the Defendant's Pension Plan.

The Plaintiff, Stacy M. Pahkamaa, f/k/a Stacy M. Skradski, did not appear personally but was represented by her attorney of record, Patrick A. Campagna of Lustgarten & Roberts, P.C., L.L.O., 1625 Farnam Plaza, Suite 900, Omaha, NE 68102.

The Defendant, John E. Skradski, pro se, did/did not appear personally. The Court being fully advised in the premises finds as follows:

- 1. The Court has continuing jurisdiction of the parties hereto and the subject matter of this action.
- 2. The Court finds that Plaintiff's Motion shall be sustained. The Defendant shall, forthwith, make contact with Michael W. Smith, Executive Director of the Omaha School Employee Retirement System, or his successor and execute any and all necessary release(s), authorization(s), and stipulation(s) to facilitate the Plaintiff's preparation of a QDRO conforming to this Court's Decree of Dissolution entered on November 9, 2010 in reference to paragraph 8(p) of said Decree.

- 3. To the extent that the Defendant fails and refuses to comply with this Court's Order, a certified copy of this Order shall serve as a substitute for the Defendant's signature on said release(s) and authorization(s) and have the same operation and effect as such required documents, as may otherwise be specifically required by the Omaha School Employees Retirement System, it's successors and/or its assigns. - 4. The Court further finds that as a result of having to file this Motion, Defendant shall pay to Plaintiff's counsel, attorneys fees in the sum of \$250. Said sum shall be paid through the Clerk of the District Court of Douglas County, Nebraska, at 1701 Farnam Street, #300, Omaha, NE 68183. The Clerk of the District Court is hereby authorized and instructed to forward the Defendant's attorney fee payment to Plaintiff's counsel at 1625 Farnam Street, Suite 900, Omaha, NE 68102.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, by the Court, that the findings of the Court as hereinabove set forth shall be the Order of this Court and the parties shall abide by and adhere to this Order.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, by the Court, that the Court finds that Plaintiff's Motion shall be sustained. The Defendant shall, forthwith, make contact with Michael W. Smith, Executive Director of the Omaha School Employee Retirement System, or his successor and execute any and all necessary release(s), authorization(s), and stipulation(s) to facilitate the Plaintiff's preparation of a QDRO conforming to this Court's Decree of Dissolution entered on November 9, 2010 in reference to paragraph 8(p) of said Decree.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, by the Court, that to the extent that the Defendant fails and refuses to comply with this Court's Order, a certified copy of this Order shall serve as a substitute for the Defendant's signature on said release(s) and authorization(s) and have the same operation and effect as such required documents, as may otherwise be specifically required by the Omaha School Employees Retirement System, it's successors and/or its assigns.
