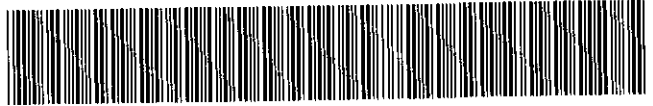

A part of Lot 1, Block 16, Mockingbird Hills, a subdivision located in the Northwest 1/4 of the Southwest 1/4 of Section 3, Township 14 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, more particularly described as follows:

Commencing at the Northwest corner of said Lot 1, Block 16, Mockingbird Hills; thence S 00 degrees 42'27" E, (assumed bearing) along the East right-of-way line of 96th Street, a distance of 175.00 feet, to the point of beginning; thence N 89 degrees 17'33" E a distance of 130.94 feet; thence N 44 degrees 57'48" E a distance of 100.17 feet; thence N 00 degrees 38'03" E a distance of 34.23 feet; thence S 89 degrees 21'57" E a distance of 120.00 feet; thence S 00 degrees 38'03" W a distance of 90.33 feet; thence S 89 degrees 21'57" E a distance of 95.00 feet; thence S 44 degrees 57'48" W a distance of 420.56 feet to a point on the Northerly line of Lot 135, Mockingbird Hills, Replat II; thence S 89 degrees 17'33" W along said Northerly line of Lot 135, Mockingbird Hills Replat II, a distance of 115.38 feet, to a point on said East right of way line of 96th Street; thence N 00 degrees 42'27" W, along said East right of way line of 96th Street a distance of 285.00 feet, to the point of beginning.
