We, the undersigned Appraisers, do hereby certify, that under and by virtue of and "Appointment of Appraisers", duly served upon us on the 12 day of Aug. 1957, by the Sheriff of Sarpy county, Nebraska; and after having taken and signed an oath to support the Constitutions of the United States of America and the State of Nebraska, to faithfully and impartially discharge our duties as required by law, and to honestly and truly assess the damages which the owners of the real estate, described in said "Appointment of Appraisers", will sustain by reason of the taking of permanent easement to certain lands for right of way, and temporary easement to certain lands for road material purposes, for the purpose of constructing a part of a National System of Interstate Highways; and also for damages due to prohibition of access to said highway; that we did inspect the real estate herein described at the time and place designated and did at said time and place sit as a Board of Appraisers and did receive evidence relative to the amount of damages that will be sustained by the owners of said real estate by reason of the taking thereof by the Department of Roads and Irrigation of the State of Nebraska; for right of way and road material purposes, and also damages due to prohibition of access to said highway; the real estate referred to above being described as follows:
