WARRANTY DEED

KNOW ALL MEN BY THESE PRESENT, that the North Central States Regional Council of Carpenters, successor by merger to the United Brotherhood of Carpenters & Joiners of America Local Union No. 444, a Nebraska non-profit, unincorporated association (as evidenced by that certain merger letter dated July 15, 2010, attached herein as Exhibit A) ("GRANTOR"), in consideration of One Dollar and other valuable consideration received from GRANTEE, does grant, bargain, sell, convey, and confirm unto the North Central States Regional Council of Carpenters ("GRANTEE"), whose legal address is 700 Olive Street, St. Paul, Minnesota 55130, the real property described in the attached Exhibit B.

To have and to hold the premises described in **Exhibit B** together with all tenements, hereditaments and appurtenances thereto belonging unto the GRANTEE and to GRANTEE's successors and assigns forever.

And GRANTOR does hereby covenant with the GRANTEE and with GRANTEE's successors and assigns that GRANTOR is lawfully seized of said premises; that they are free from encumbrance, except those easements, restrictions and covenants of record.

That GRANTOR has good right and lawful authority to convey the same; and that GRANTOR warrants and will defend the title to said premises against the lawful claims of all persons whomsoever.

TO: BANKS AND OTHER FINANCIAL INSTITUTIONS HOLDING ASSETS OF OR ON BEHALF OF KANSAS CITY AND VICINITY DISTRICT COUNCIL OF CARPENTERS, UNITED BROTHERHOOD OF CARPENTERS AND JOINERS OF AMERICA

As General President of the United Brotherhood of Carpenters and Joiners of America ("UBC"), I hereby notify all interested parties that the UBC has directed that its subordinate body, Kansas City and Vicinity District Council of Carpenters, be dissolved. UBC officials have been assigned to oversee the dissolution described herein. (A copy of my letter, dated July 15, 2010, directing this dissolution is attached.)

Kansas City and Vicinity District Council of Carpenters is dissolved effective July 20, 2010, pursuant to Section 6(A) of the UBC Constitution. A copy of this section, and Section 30, of the UBC Constitution is attached.

Mr. Bobby J. Yeggy, who is UBC District Vice President for the Midwestern District, and/or Mr. Jerry Alander, who is a UBC District Representative, have full authority to administer to the dissolution of Kansas City and Vicinity District Council of Carpenters, including authority over any persons previously designated as authorized signatories for any accounts of Kansas City and Vicinity District Council of Carpenters.

Accordingly, you are hereby notified that all previous signature authorizations with respect to accounts of Kansas City and Vicinity District Council of Carpenters are hereby formally rescinded. Effective immediately, Messrs. Yeggy and/or Alander have full and exclusive authority to control and issue instructions with respect to the assets and property of Kansas City and Vicinity District Council of Carpenters. Upon receipt of this notice, you are to make no disbursements from Kansas City and Vicinity District Council of Carpenters accounts, except as authorized by Messrs. Yeggy and/or Alander.

Messrs. Yeggy and/or Alander will sign such forms as you may need to establish and confirm the duly authorized signatures with respect to accounts and assets of Kansas City and Vicinity District Council of Carpenters.

Dear Sir and Brother:

I am in receipt of a report and recommendation regarding the Kansas City and Vicinity District Council of Carpenters ("Kansas City Council") prepared by Phil Newkirk, Assistant to the General President. Brother Newkirk recommended that the Kansas City Council be dissolved and its jurisdiction and affiliated Local Unions be merged into the Southwest Regional Council of Carpenters, St. Louis, Missouri District Council of Carpenters, and the North Central States Regional Council of Carpenters, as described herein.

After review and consideration, I have determined that it would be in the best interests of the UBC and its membership to implement the recommendation. Accordingly, pursuant to my authority under Section 6(A) of the UBC Constitution, I hereby dissolve the Kansas City Council and merge its operations and jurisdiction into the Southwest Regional Council of Carpenters, St. Louis, Missouri District Council of Carpenters, and the North Central States Regional Council of Carpenters, as described herein, effective July 20, 2010.

Specifically, the geographical and trade jurisdiction for the State of Colorado is hereby merged into the Southwest Regional Council of Carpenters. Local Unions 55, 244, 510, 515, and 2834 are hereby affiliated with the Southwest Regional Council of Carpenters.

The geographical and trade jurisdiction for the States of Kansas and that portion of Missouri presently within the jurisdiction of the Kansas City Council is hereby merged into the St. Louis, Missouri District Council of Carpenters. Local Unions 168, 201, 714, 918, 61, 1445, 1529, 9027, 1635, 110, 311, 777, 945, 978, 1181, 1329, 1904, and 1925, are hereby affiliated with the St. Louis, Missouri District Council of Carpenters.

The geographical and trade jurisdiction for the States of Nebraska and that portion of Iowa presently within the jurisdiction of the Kansas City Council is hereby merged into the North Central States Regional Council of Carpenters. Local Unions 444, 1463, 1055, 106, and 948 are hereby affiliated with the North Central States Regional Council of Carpenters.

The vested rights of the members shall be preserved.

Pursuant to Section 30(A) of the UBC Constitution, effective July 20, 2010, I hereby direct that the real property held by or on behalf of the Kansas City Council be divided as follows: real property in Colorado is given to the Southwest Regional Council of Carpenters; real property in Missouri and Kansas is given to the St. Louis, Missouri District Council of Carpenters; and, real property in Nebraska and Iowa is given to the North Central States Regional Council of Carpenters. Furthermore, all books, records, property (other than real property), accounts, and other assets of the Kansas City Council is provided to the UBC, to be divided at a later time amongst the Southwest Regional Council of Carpenters, the St. Louis, Missouri District Council of Carpenters, and the North Central States Regional Council of Carpenters. The Charter of the dissolved Kansas City Council shall be returned to the UBC.

Finally, Section 10(M) of the UBC Constitution provides, in its entirety, that "(t)he General President shall have authority to appoint interim officers and delegates of newly established, consolidated or merged Local Unions or Councils." I will appoint interim delegates to the Southwest Regional Council of Carpenters, St. Louis, Missouri District Council of Carpenters, and the North Central States Regional Council of Carpenters, from the Local Unions formerly affiliated with the Kansas City Council, as described herein under separate cover.
