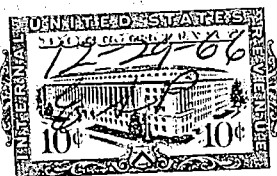
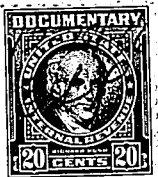


KNOW ALL MEN BY THESE PRESENTS, That ESTHER STUART PARSLEY, widow,

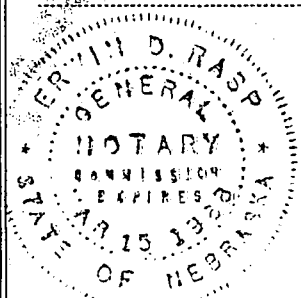

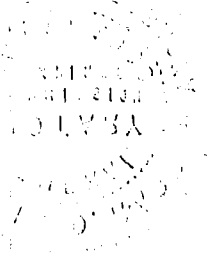
