KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, THE FIRST NATIONAL BANK OF FORT SMITH, Fort Smith, Arkansas, made a loan to WALLY PROPERTIES, LLC in the amount of ONE MILLION NINE HUNDRED SIXTY EIGHT AND 00/100 (\$1,968,000.00) evidenced by Promissory Note Number 2472706 and mortgage covering:

recorded on December 16, 2003, Doc #2003241053 in the office of the Clerk in Omaha, Douglas County, state of Nebraska; and

WHEREAS, the parties hereto, for mutual consideration, wish to modify the payment terms of said indebtedness.

THEREFORE, it is agreed that the unpaid balance of said indebtedness is \$1,968,000.00 in Principal; and the undersigned hereby promise to pay said indebtedness with interest at the rate of **First National Bank base rate adjusted monthly** as follows:

PAYMENT: This note is due on demand, or if no demand is made, accrued interest payable in installments beginning January 11, 2006 and all subsequent payments due on the same day of each Month thereafter. Principal plus all unpaid accrued interest and late charges are due in full on March 11, 2006.

LATE CHARGE: If a payment is more than ten (10) days late, Borrower will be charged a late fee of 10.00% of the payment or \$100.00, whichever is less.

In all other respects the said note and mortgage shall remain in full force and effect and the undersigned promises to pay said indebtedness as herein stated and to perform all of the obligations of said mortgage contract as herein revised.

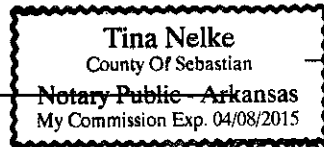

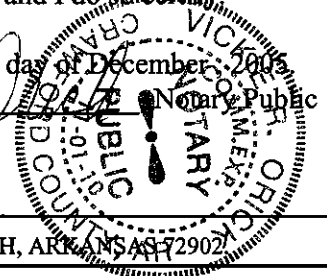
