It was moved by Gaer, second by Sieman concurrence with Plan and Zoning Commission's recommendation for approval of the Preliminary Site Plan subject to the following recommendations:

- 1. Five (5) feet of additional ROW along Lake Drive be dedicated to the City by deed prior to the issuance of a building permit;
- 2. A five (5) foot parking setback at the adjoining lot line;
- 3. Joint access easement being recorded prior to the issuance of a building permit;
- 4. The site is restricted to tenants that will meet the parking requirements;
- 5. The restaurants be limited to sit down, non fast food restaurants/delis/donut shops;
- 6. Coordinate with Parks & Recreation Department for the construction of the public recreation trail. Forty percent (40%) of the cost of the public recreation trail will be funded by the developer, with the City paying for sixty percent (60%). The applicant will have all responsibility for the private trail extending west from the public trail;
- 7. Additional landscaping is illustrated on the site plan to provide screening of the parking lot along Lake Drive before proceeding to City Council; and
- 8. Waiver of the parking set back along Lake Drive only, from twenty (20) feet to fifteen (15) feet.
