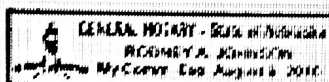


EXHIBIT "B"

The SE 1/4 of Section 25, Township 17 North, Range 7 East of the 6th P.M.,
Saunders County, Nebraska, **EXCEPT:**

That part of the Northwest Quarter of the Southeast Quarter of Section 25, Township 17 North, Range 7 East of the Sixth Principal Meridian, Saunders County, Nebraska; described as beginning at the Northwest Corner of the Southeast Quarter of Section 25; thence N90-00-00E (assumed bearing), on the North line of the Southeast Quarter, a distance of 983.99 feet; thence S00-00-13W, a distance of 328.50 feet; thence S90-00-00W, on a line parallel to the North line of the Southeast Quarter, a distance of 984.01 feet to a point on the West line of the Southeast Quarter, thence N00-00-27E, on the West line of the Southeast Quarter, a distance of 328.50 feet to the point of beginning, **AND ALSO EXCEPT:**

That part of the North 1/2 of the Southeast 1/4 of Section 25, all in T17N, R7E of the 6th P.M., Saunders County, Nebraska, more particularly described as follows: Commencing at the center of said Section 25; thence N90-00-00E (assumed bearing) along the North line of said Southeast 1/4 for 983.92 feet to the point of beginning; thence continuing N90-00-00E along said North line for 281.00 feet; thence N00-00-00E along said North line 704.04 feet; thence S00-22-13E 309.55 feet; thence S00-00-00E 19.00 feet; thence S90-00-00W 985.04 feet; thence N00-00-00W 328.54 feet to the point of beginning.
