

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

THAT we, Christian R. Trofolz, husband and wife, as joint tenants, and not as toward in common the following tenants. and not as tenants in common; the following described real estate, situated in the County of Douglas and State of Nebraska, to-wit:

> The East One-Half (E 1/2) of the Northwest One-Quarter (NW 1/4) of Section Ten (10), Township Fifteen North (15 N), Range Eleven (11), East of the 6th P.M., Douglas County, Nebraska,

together with all tenements, hereditaments and appurtenances to the same belonging, and all the estate, title, dollar, right of homestead, claim or demand whatsoever of the said Grantors, of, in or to the same, or any part thereof; subject to easements and restrictions of record, said Grantors to pay assessments and taxes assessed to and including the year 1968.


