QUIT CLAIM DEED - Municipal Corporation

THIS INDENTURE, made this 17th day of June, A.D. 1976, between THE CITY OF OMAHA, a Municipal Corporation organized under and by virtue of the laws of the State of Nebraska, Party of the First Part, and MICKLIN LUMBER COMPANY, INC., a Nebraska Corporation, situated in the County of Douglas and State of Nebraska, Party of the Second Part,

WITNESSETH:

That the said Party of the First Part, for and in consideration of the sum of One (\$1.00) Dollar and other good consideration, in hand paid, receipt whereof is hereby acknowledged, has sold and by these presents does quit-claim, grant, convey, and confirm unto the said Party of the Second Part, the following described premises, situated in the City of Omaha, County of Douglas, State of Nebraska, to-wit:

14 feet of vacated 19th Street abutting along the East 1/2 of Lot 1, of Block 195½, Original City of Omaha, as surveyed and lithographed, in Douglas County, Nebraska.

TO HAVE AND TO HOLD the said premises above-described together with all the Tenements, Hereditaments, and Appurtenances thereunto belonging unto the said Micklin Lumber Company, Inc., a Nebraska Corporation, its successors and assigns forever.

And the said THE CITY OF OMAHA, a Municipal Corporation, for itself or its successors and assigns, does hereby agree to and with the said Party of the Second Part and its successors and assigns, that neither it nor any person in its name and behalf, shall or will hereafter claim or demand any right or title to the said premises or any part thereof, but they and every one of them shall these presents be excluded and forever barred.

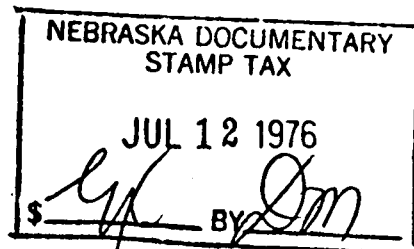

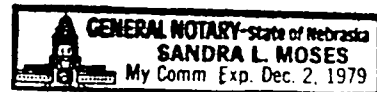
