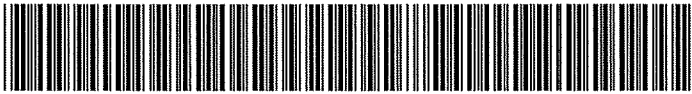

### **PARTIAL RELEASE OF PLATTED UTILITY EASEMENT**

This Partial Release of Platted Utility Easement ("Release") is made by Qwest Corporation d/b/a CenturyLink QC ("CenturyLink").

#### **BACKGROUND:**

A. A utility easement created by Vacation Ordinance 30998 being the Ease/West alley between Iward Street and Nicholas St. from 19<sup>th</sup> Street (Florence Boulevard to 20<sup>th</sup> Street abutted by Lots 1 through 8, inclusive and vacated 19<sup>th</sup> Street adjacent, Block 195 1/2 , Original City of Omaha, an addition to the City of Omaha, Douglas County Nebraska.
