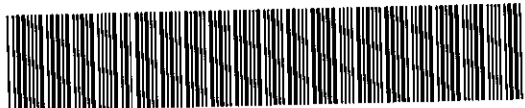

and subject to easements and restrictions of record.

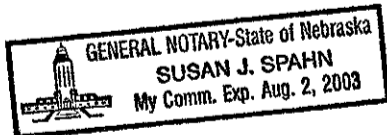
