

SURVEYOR'S CERTIFICATE

OF A CURVE TO THE LEFT HAVING A RADIUS OF 102.02' WITH AN INTERNAL ANGLE OF 51° 26'00" THENCE RUNNING SOUTHEASTERLY ALONG THE ARC OF SAID CURVE 91.37' TO THE P.T. OF SAID CURVE THENCETURNING AN ANGLE OF 9000'00" TO THE RIGHT FROM THE TANGENT OF SAID CURVE AND RUNNING SOUTHWESTERLY 200.0' TO A POINT ON THE NORTHERLY RIGHT OF WAY LINE OF THE CHICAGO AND NORTHWESTERN RAILWAY THENCE NORTHWESTERLY ALONG SAID RIGHT OF WAY LINE 553.0' TO THE EAST PROP-ERTY LINE OF 56TH STREET ALSO KNOWN AS MORMON BRIDGE ROAD THENCE NORTH ALONG SAID EAST PROPERTY LINE 851.91' TO THE POINT OF BEGINNING.
