MODIFICATION AGREEMENT

This modification is intended only to change the referenced dollar amount of the maximum obligation limit in the original Assignment of Leases and Rents dated February 3, 2010, filed February 8, 2010 in Douglas County at 2010011453, but is not intended to change any other terms of that agreement, or limit any of AIB's rights in, or to, the collateral including, but not limited to, the references to "All Debts" as contained in the original Assignment of Leases and Rents.

By signing, Lehn Land, L.L.C., hereby agree to the terms of this Modification Agreement and acknowledge the receipt of a copy of said agreement.


