THIS THIRD AMENDMENT TO MASTER DEED AND DECLARATION ~~WF2~~ CONDOMINIUM ASSOCIATION PROPERTY REGIME (the "Amendment") made this 27th day of April, 2006 by Westfield Office Building II, LLC, a Nebraska limited liability company ("Developer").

RECITALS

A. Developer has previously executed that certain Master Deed and Declaration ~~WF2~~ Condominium Association Property Regime, recorded November 2, 2005, in Instrument 2005138541, in the records of the Register of Deeds of Douglas County, Nebraska (the "Declaration").

B. The Declaration affects that certain real property located in Douglas County, Nebraska and more particularly described as follows:

Lot 4, Westroads Replat 4, an Addition to the City of Omaha, Douglas County, Nebraska now known as Apartment 1-W-1,1-E-1, 2-W-1, 2-E-1, 2-E-2, 3-W-1, 3-E-1, ~~WF2~~ Condominium Association Property Regime.

C. Developer has previously executed that certain First Amendment to the Master Deed and Declaration ~~WF2~~ Condominium Association Property Regime, Dated November 18, 2005 in Instrument 2005147515.

E. Developer desires to amend the Declaration as provided herein.

WHEREFORE, Developer hereby amends the Declaration as follows:

1. The Third Restatement of Schedule "B", Shareholder's of W F 2 Condominium Association is attached hereto and by this reference is hereby made a part hereof. This Third Restatement shall replace the original Schedule B and the First and Second Restatement of Schedule B.



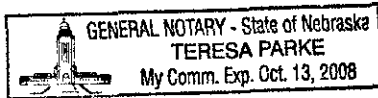
