



SURVEYOR CERTIFICATE

I hereby certify that I have accurately surveyed and staked the lots, blocks, streets and pedestrian and drainage ways of Tower Plaza as shown on this plat, and that the same is located in and occupies that part of the North West 1/4 of Section 23, Township 15 N Range 12 East of the 6th Principal Meridian, Douglas County, Nebraska, described and bounded as follows:

Beginning at a point at the intersection of the east line of 84th St and the south line of Cass St, said point being 33 feet east and 33 feet south of the Northwest corner of said section 23, and running thence east on a line 33 feet south of and parallel to the north line of said section 23, 1398.9 feet more or less to the westerly line of 78th St; thence S 24° 58' E on the present westerly line of 78th St, 1058.9 feet more or less to the north line of Beverly Hills as surveyed, platted and recorded; thence west on the north line of said Beverly Hills 903.6 feet more or less to the northerly line of Nebraska State Highway No. 30A; thence northwesterly on the northerly line of said highway 1065.45 feet more or less to the east line of 84th St; thence north on the east line of 84th St, 465.95 feet to the place of beginning.
