# **RELEASE AND QUITCLAIM**

THIS Release and Quitclaim is made this 30<sup>th</sup> day of September, 2008, between UNION PACIFIC RAILROAD COMPANY, a Delaware corporation (successor in interest to Union Pacific Railroad Company, a Utah corporation, successor in interest to Chicago and North Western Railway Company) ("Grantor"), and WRK, L.L.C., a Nebraska limited liability company ("Grantee").

#### RECITALS

WHEREAS, Grantee desires the cancellation and release of the Deed Reservation located on the Property, and Grantor is willing to release and quitclaim its right, title and interest in the Deed Reservation.

NOW, THEREFORE, Grantor, in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, to it in hand paid, the receipt of which is hereby confessed and acknowledged, for itself, its successors and assigns, does hereby REMISE, RELEASE AND QUITCLAIM to Grantee, its successors and assigns, forever, all of Grantor's right, title and interest in and to Deed Reservation to the extent it affects the Property only, it being the intent hereof to release only Grantor's right, title and interest in and to the Deed Reservation with respect to the Property, and to leave in full force and effect all other provisions of the 1967 Deed, and all other rights reserved therein.

## **Legal Description**
