## MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT (this "Memorandum") is made as of the Effective Date (as hereinafter defined) by and between Zone 5, LLC, a Nebraska limited liability company ("Seller") and Aksarben Lodging, LLC, a Nebraska limited liability company ("Buyer"). NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby mutually acknowledged, Seller and Buyer agree as follows:

- 1. <u>Purpose</u>. The purpose of this Memorandum is to give record notice of the Agreement and of the rights created thereby, all of which are hereby confirmed. This Memorandum is for notice purposes only and is not a complete summary of the Agreement.   - 2. Term. The Agreement shall expire on January 1, 2021.
- 3. <u>Miscellaneous</u>. This Memorandum shall be governed and construed in accordance with the laws of the State of Nebraska. Initially capitalized terms not otherwise defined herein shall have their respective meanings set forth in the Agreement.
