EASEMENT

The undersigned, hereinafter called "Grantor," hereby grants and conveys to OMAHA PUBLIC POWER DISTRICT, hereinafter called "District," its successors and assigns, a perpetual easement to construct, operate and maintain a __3 phase __69 kilo-volt electric transmission line, together with necessary poles, wires, guys and other fixtures and appliances, over, upon, along and above the property herein described, upon the terms and conditions set forth.

CONSIDERATIONS: - Three Handred and of 17/100 - Dollars (\$300 =)
PROPERTY COVERED AND RIGHT-OF-WAY:

The North 27.44 acres of the South 1/2 of the Southwest Quarter, and the South 25.63 acres of the South 1/2 of the Southwest Quarter, and the North 1/2 of the Southwest Quarter, and the South 1/2 of the Northwest Quarter, Section 25, Township 15 North, Range 12 East, Douglas County, Nebraska.

Beginning at a point Ten (10) feet more or less North and Two (2) feet more or less West of the Southeast corner of the above described property, thence Northerly and parallel with the North-South one-half Section Line, Section 35, to a point on the North line of the above described property, said point being Two (2) feet more or less Westerly of the Northeast corner of the South 1/2 of the Northwest Quarter, Section 35.

The wood pole structures to be placed on the above described premises shall not exceed eleven (11) structures and four (4) down guys and anchors in number, except that one additional wood pole structure may be set upon said premises upon additional payment of \$25.00 per structure to Grantors, their successors or assigns.

CONDITIONS: The Grantor hereby grants to the District, its successors and assigns, the right, privilege and authority to enter upon and pass over said property and the property of the Grantor adjacent thereto for the purpose of constructing, repairing, operating and maintaining said lines and equipment upon the property above described.

The Grantor hereby grants to the District, its successors and assigns, the permanent right, privilege and authority to cut down trees under or within twenty-five (25) feet of the District's lines, and to cut down or trim any trees or limbs of trees on either side thereof as would be a hazard to said lines in breaking off and falling over or against said lines. All refuse or debris from such tree cutting and trimming shall be disposed of by burning.

The District shall at all times exercise all due care and diligence to avoid any injury or damage to the crops, live stock and other personal property of the Grantor and the District agrees to indemnify and save harmless the Grantor from any and all such damage and loss arising or occurring to such property solely by reason of the District's negligence in the construction, operation and maintenance of said electric line.

This easement is binding on the heirs, executors, administrators and assigns of Grantors.
