AN ORDINANCE OF THE CITY OF HASTINGS, NEBRASKA TO EXTEND THE BOUNDARIES AND INCLUDE WITHIN THE CORPORATE LIMITS OF, AND TO ANNEX TO THE CITY OF HASTINGS, CERTAIN LAND IN THE NORTHEAST QUARTER (NE/4) OF SECTION ONE (1), TOWNSHIP SEVEN (7) NORTH, RANGE TEN (10) WEST OF THE 6TH P.M., IN ADAMS COUNTY, NEBRASKA: TO PROVIDE FOR SERVICE BENEFITS THERETO; TO CONFIRM THE ZONING CLASSIFICATION THEREOF, AND TO DECLARE AN EMERGENCY.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HASTINGS, NEBRASKA:

SECTION 1. It is hereby found and determined by such Council

that:

- (a) The tract, more particularly described hereafter, located in the Northeast Quarter (NE/4) of Section One (1) Township Seven (7) North, Range Ten (10) West of the 6th P.M., in Adams County, Nebraska, is urban and suburban in character, is contiguous and adjacent to the American Legion Memorial Wayside State Park which is contiguous and adjacent to the corporate limits of the City of Hastings;
- (b) Police, fire and snow removal benefits will be immediately available thereto, and City utility services will be available upon the owner of the said tract executing an agreement to pay all costs to extend existing utility facilities to the said tract.
- (c) Such tract has the zoning classification of M-1 Light Industry, by virtue of zoning ordinance of the Hastings Municipal Code; and
- (d) There is a unity of interest in the use of such tract with the use of lots and tracts in such City and the community convenience and welfare and the interest of such City will be enhanced through incorporating such tract within the limits of such City.
- SECTION 2. That the boundaries of the City of Hastings, Nebraska, be, and hereby are, extended to include within the corporate limits of said City the tract located in the Northeast Quarter (NE/4) of Section One (1), Township Seven (7) North, Range Ten (10) West of the 6th P.M., in Adams County, Nebraska, more particularly described as follows:

SECTION 5. Since an emergency exists this ordinance shall take effect from and after its passage and publication as provided by law.
