ORDER TO DELIVER NON-EXEMPT FUNDS

Upon application of the judgment creditor, the court finds:

- 1a. That the judgment debtor is an employee of the garnishee, and the garnishee owed earnings to the judgment debtor when the garnishment order was served, or
- 1b. That the garnishee has property, credits, or money belonging to the judgment debtor other than earnings, and
2. That there is not a successful written objection to the order or the answer of the garnishee filed, and
3. That the judgment debtor was not already being garnished pursuant to a continuing lien at the time the garnishment was served.

THE COURT THEREFORE ORDERS that the non-exempt funds withheld by the garnishee in the amount of \$ \$1,736.14 be transferred to the court for payment to the judgment creditor. Upon compliance with this order, the garnishee is released and discharged. Checks shall be made payable to the judgment creditor.
