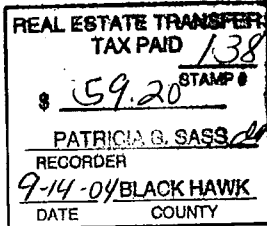
do hereby Convey to Roosevelt Housing Partners, LP
