FIRST AMENDMENT TO MASTER DEED AND DECLARATION CREATING SWANSON TOWERS CONDOMINIUM PROPERTY REGIME

THIS FIRST AMENDMENT made this 18 day of May , 1988, to the Master Deed and Declaration Creating Swanson Towers Condominium Property Regime, by Creative Land Investments, Inc., dated January 10, 1978, and recorded with the Douglas County Register of Deeds on January 11, 1978, in Deeds Book 1587 at Page 613.

WHEREAS, the Annual Meeting of the Swanson Towers Condominium Property Regime and Swanson Towers Association, Inc. was duly called and held on May 9, 1988; and

WHEREAS, by vote of more than three-fourths (3/4) of the Unit Owners of the total basic value of the Swanson Towers Condominium Property Regime, by ballot, in person, and by proxy, the amendments to the Master Deed and Declaration Creating Swanson Towers Condominium Property Regime set forth below were approved and adopted in compliance with the provisions of Paragraph X of said Master Deed and Declaration.

NOW, THEREFORE, the undersigned, for and by authority of the above-mentioned Swanson Towers Condominium Property Regime and Swanson Towers Association, Inc., amend the Master Deed and Declaration creating Swanson Towers Condominium Property Regime dated January 10, 1978, as follows:

- (1) Paragraphs X(k) and X(l) as they appear in the Master Deed and Declaration dated January 10, 1978, are hereby deleted in their entirety.
- (2) Paragraph X(k) of the Master Deed and Declaration dated January 10, 1978, shall now read:

"(k) All notices required hereby shall be in writing and shall be delivered to or sent by registered or certified mail to the Board of Administrators c/o the managing agent, or if there is no managing agent, to the office of the Board of Administrators or to such other address as the Board of Administrators may hereafter designate from time to time, by notice in writing to all unit owners. All notices to any unit owner shall be delivered to or sent by first class mail, postage prepaid, to the building or to such other address as may have been designated by the unit owner, from time to time, in writing to the Board of Administrators. All notices shall be deemed to have been given when delivered or mailed."
